the following resolution is hereby adopted:

**A RESOLUTION OF THE BOARD OF DIRECTORS
OF THE
APTOS/LA SELVA FIRE PROTECTION DISTRICT
ACCEPTING AND CONFIRMING THE REPORT OF PROPERTY OWNERS
AND SPECIFIC ASSESSED COSTS FOR ABATING WEEDS AND NUISANCES
TO BE COLLECTED ON THE TAX ROLL**

WHEREAS, Aptos/La Selva Fire District (the District) Ordinance 1-91 Sections 2.6, 2.7, 2.8, and 2.9 specify the ways for Accounting and Reporting Costs of weed and nuisance abatement, Notice of Report and of Hearing for assessment for Weed Abatement, Hearing and Confirmation of Assessment for Weed Abatement, and Collection on Tax roll, respectively; and,

WHEREAS, the District has complied with the requirements of Ordinance 1-91 Sections 2.6, 2.7 and 2.8; and,

WHEREAS, the Report of Cost is attached to this resolution as Exhibit A; and,

WHEREAS, this resolution is intended to meet the requirements of Ordinance 1-91 Section 2.9,


NOW, THEREFORE, BE IT RESOLVED AND ORDERED, that the Report of Cost (Exhibit A) be filed with the County Auditor, County Assessor, and Tax Collector on or before the 10th of August 2016 in order that each such assessment may be entered on the County Tax Roll opposite the parcel of land. Therefore, such amounts may be collected at the same time, and in the same manner, as taxes are collected and shall be subject to the same penalties and interest, and the same procedure and sale in case of delinquency as provided by law for such taxes. All laws and ordinances applicable to the levy, collection and enforcement of County taxes are made applicable to such special assessment, except that if any real property to which such lien would attach has been transferred or conveyed to a bona fide purchase for value, or if a lien of a bona fide encumbrancer for value has been created and attached thereon, prior to the date on which the first installment of such taxes would become delinquent, then the lien which would have otherwise be imposed by this section shall not attach to such real property

and the costs of abatement and the costs of enforcing abatement, as confirmed, relating to such property shall be transferred to the unsecured tax roll for collection.


