The following Resolution is adopted.

RESOLUTION ESTABLISHING FEES FOR PERMITS AND SERVICES

WHEREAS, the Board of Directors of Central Fire Protection District of Santa Cruz County adopted Ordinance No. 98-01, pursuant to Health and Safety Code Section 13916 et. seq., prescribing for the charging and collection of fees to cover the cost of any service which the District provides or the cost of enforcing any regulation for which the fee is charged; and,

WHEREAS, the District is further authorized to issue permits required by Chapter 1, Section 105 of the California Fire Code to maintain, store, use, or handle materials, or to conduct processes which produce conditions hazardous to life or property, or to install equipment used in connection with such activities; and,

WHEREAS, fees shall not exceed the estimated reasonable cost of enforcing the regulation or providing the service for which the fee is charged. The fees will be based on a minimum charge of one hour, unless otherwise identified on the schedule.

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Directors of Central Fire Protection District establishes the following schedule of fees and will be considered the current schedule prescribing **Resolution No. 2017-15** appropriate charges, until otherwise superseded, for the following:

A. Building Plan Check

Reviews, plan checks, inspections of new construction, tenant improvements,

remodels and additions (including, but **not** limited to carports, garages and decks) as required in the California Fire Code.

***square footage calculations are based on a minimum fee of \$172.50. Calculations of properties over 50,000 square feet shall be done on an individual basis at the discretion of the Fire Marshal.**

F. Discretionary/Minor Land Division Plan Check:

\$150.00/hr.

G. Additional Plan Checks

1. Resubmittal (Third Attempt): **100% of original fee**

2. Construction or Installation Prior to Plan Approval: **100% of original fee**

H. Field Appointments:

1. Missed Appointments (15 min. wait time): **\$127.50 per appt.**

2. Excessive Appointments (more than two per test): **\$127.50 per appt.**

3. Unprepared for Scheduled Appointment: **\$127.50 per appt.**

4. After-Hours Appointment: **\$127.50 minimum
(or rate of Inspector
@1 ½ rate outside of
regular work hours)**

1. Escrow Inspection Clearance: **\$127.50 (min. 1 hr.)**




