the following Resolution is adopted.

RESOLUTION AMENDING THE MASTER SALARY SCHEDULE

WHEREAS, California Code Regulations (CCR), Title 2, Sections 570. 5 and 571(b) were adopted by CalPERS to provide specific requirements on how public agencies should document payrates and special compensation items; and

WHEREAS, to comply with 2 CCR 570. 5, the District's salary schedule listing all titles for every employee position, payrates for each position, and the time base for each payrate must be adopted by the employer;

WHEREAS, to comply with 2 CCR 571(b), the District is required to consolidate all salary into one document that must be adopted by the Board of Directors; and

WHEREAS, the Master Salary Schedule was previously prepared, publicly available, and compiled from information that was already approved and adopted by the Board of Directors of Central Fire District of Santa Cruz County; and


WHEREAS the Board of Directors of Central Fire District of Santa Cruz County approved Resolution 2021-11 adopting the Master Salary Schedule and Resolution 2023-03 Amending the Master Salary Schedule; and




NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the Board of Directors of the Central Fire District adopts the attached amended master salary schedule;
